

Conditions: “Share your love for /e/OS” give away

1. Eligibility

Who can enter: This contest is open to individuals who are at least 18 years old (or the age of majority in their jurisdiction).

Geographic Restrictions: Participation is permitted in all regions. However, for regions where the distribution of physical hardware (the Murena Fairphone (Gen.6) & Fairbuds XL) is restricted due to local laws, import regulations, or logistical limitations, participants are automatically entered for the **Murena Workspace 2TB Plan prize for 2 years only**.

The Murena Fairphone (Gen.6) & Fairbuds XL are available in the following regions: UK, the European Union, Norway, Iceland, Switzerland, Liechtenstein, and the USA.

2. How to Enter

Submission: To enter, participants must record and submit a video clip no longer than 30 seconds.

Content: The video should showcase why the participant recommends the operating system /e/OS or any Murena product, such as Murena smartphones, Murena Workspace, Murena MDM or Murena as a brand. The video must be in English or with English subtitles.

Submission Method: Videos must be sent to media@murena.com and can be shared in advance on Mastodon, Bluesky, Facebook, LinkedIn or X. If the video or link is shared publicly, the official Murena account on the platform must be tagged. For the finals selected participants will be asked to agree on their video being shared publicly.

Deadline: All submissions must be received by May 24, 2026, 00:00 CEST. Late entries will be disqualified.

3. Selection Process

Shortlisting: The organizing team will review all valid submissions and select the top 3 finalists based on originality and adherence to the 30-second limit.

Community Voting: The shortlisted videos will be presented during the official live stream presentation of the /e/OS 4.0 in early June, 2026. During the stream, the community will vote online for their favorite entry. Votes are counted per unique account per platform. Platforms where to vote will be announced shortly.

Voting Window: Voting will be open for a strictly defined period announced during the live stream. Votes cast after the deadline will not be counted.

Winners: The winner(s) will be determined by the highest number of valid votes received during the voting window. In the event of a tie, the organizing team reserves the right to use a secondary tie-breaker method (e.g., random draw among tied entries).

4. Prizes

Grand Prize: The winner(s) will receive one of the following, depending on eligibility:

Option A: A new Murena Fairphone (Gen.6) running /e/OS and Fairbuds XL.

Option B: A 2TB Workspace Plan subscription for 2 years (if the smartphone is unavailable in the winner's region or if the winner prefers a Workspace Plan to a smartphone for any reason).

Prize Flexibility: Winners residing in eligible regions may choose between receiving the Murena Fairphone (Gen.6) and Fairbuds XL or the Workspace Plan. Winners in restricted regions will automatically receive the Workspace Plan.

No cash substitution is allowed.

Taxes: Prizes may be subject to local taxes or duties depending on the winner's jurisdiction. Any such costs are the sole responsibility of the winner.

5. Announcement

Live Reveal: The winners will be announced live during Murena's live stream event in early June, 2026.

Notification: Winners will also be contacted privately via Email and the social media channel they contacted us with shortly after the live announcement. Winners must respond within 30 days to claim their prize, or the prize may be forfeited.

6. General Terms

Disqualification: The organizers reserve the right to disqualify any participant who attempts to manipulate the voting process, submits fraudulent entries, or violates these rules. Each participant can send only one video.

Privacy: By entering, participants agree to the use of their submitted video and confirmed name or provided nick name for promotional purposes related to the contest.

Modifications: The organizers reserve the right to modify, suspend, or terminate the contest at any time due to unforeseen circumstances.

Governing Law: These rules are governed by the laws of France.
